Terry Johnson - Quilts of Valor

Terry Johnson was introduced by Shannon Merkel. She presented information on the Quilts of Valor Foundation, a nationwide organization that awards healing quilts to servicemen and women who have been touched by war. She has quilted for more than 40 years and started the Illinois Valley chapter 4 years ago. In 2016, she made her first quilt, and it was presented to her father, an Air Force veteran who served in the Korean conflict. Terry shares that quilt with each presentation that she gives. The goal of the local chapter is to complete 130 quilts each year. Anyone can be nominated to receive one as long as they served their country and received an honorable discharge. During the meeting, Terry presented two quilts — the first to Joe Park who served in the IL Army National Guard and the second to Terry Johnson who served with the Air Force during the Vietnam era. Both men were wrapped in their quilts as Terry shared their stories. Congratulations, gentlemen, and THANK YOU for your service!

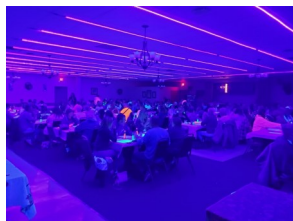
